Ordering of the Agenda

The President and Executive Director reviewed the agenda prior to the meeting

President's Report

President Capretta welcomed guests attending the meeting.

President Capretta thanked Director Manns for making arrangements for the presentation provided by Susan Nagel, Esq., Deputy Director, DAS, "Know Thy Self" on Wed., October 18, 2006 7-9 PM.

Approval of Minutes

IT WAS MOVED BY JOE BITONTE AND SECONDED BY MICHAEL HALL THAT THE MINUTES OF THE AUGUST 16-17, 2006 BOARD MEETING BE APPROVED AS AMENDED. MOTION ADOPTED BY UNANIMOUS VOTE OF THE BOARD MEMBERS.

Executive Director's Report

Executive Director Manns informed the Board that the Draft of the FY 2006Annual Report was included in their Board packet for review.

After discussion,

IT WAS MOVED BY DR. TODD CLARK AND SECONDED BY BOB CLEGG THAT THE ANNUAL REPORT FOR FY 2006 BE ACCEPTED. MOTION ADOPTED BY UNANIMOUS VOTE OF THE BOARD MEMBERS.

Director Manns also informed the Board that she had mailed to all Board members the evaluation forms for the annual performance evaluation of the executive director as well as a copy of the Executive Director Evaluation policy. Ms. Manns reminded the Board members that the completed evaluations were to be sent to President Capretta by October 31, 2006 in the addressed envelopes that were provided.

Executive Director Manns informed the Board that she and Investigator Lehman had attended the East-West Eye Conference, Cleveland, October 13/14, 2006. It was reported to the Board that a record number of Opticians had attended this meeting.

Director Manns informed the Board that beginning December 18, 2006, the State of Ohio will be implementing a new web-based computer system for all State of Ohio Agencies. This computer system, the Ohio Administrative Knowledge System, (OAKS) is designed to streamline and modernize basic administrative functions for state agencies and their employees and Board members. Beginning Jan. 5, 2007, all State of Ohio employees and Board members will receive their pay stubs electronically through OAKS. ePay is a self-service product designed to allow employees and Board members to safely and securely view their paycheck information. Ms. Manns informed Board members that she would provide additional information about accessing this web-based information as it becomes available.

Open Forum:

Ms. Angie Muldoon, Optical Compliance Manager of Wal-Mart, Optical Division, provided a presentation to Board members and members of the audience concerning Wal-Mart's process that reflects the Board's interpretation of current law for entering a prescription for contact lens into the Wal-Mart computer system. Ms. Muldoon provided information for the Board to consider that would alter their current process, but would still require verification by the appropriately licensed individual of the data entry prior to distribution to the consumer in a timelier manner. The Board agreed to take the information provided at the presentation under advisement and informed Ms. Muldoon that the Board would discuss this at the December, 2006 Board meeting.

Director Manns and P. R. Casey, AAG, discussed proposed language revisions for the definition of "Optical Aid". After discussion,

IT WAS MOVED BY BOB CLEGG AND SECONDED BY OSCAR WATSON THAT THE BOARD APPROVE AS AMENDED THE DEFINITION OF OPTICAL AID AS PUT FORWARD TO READ:

"OPTICAL AID" MEANS

- 1. A NON-CONTACT INSTRUMENT OR DEVICE PRESCRIBED BY A PHYSICIAN OR OPTOMETRIST THAT MAY AID OR CORRECT HUMAN VISION, INCLUDING SPECTACLES:
- 2. ANY CONTACT DEVICES IN OR ON THE EYE OR ORBIT, WHETHER IT ADDRESSES VISUAL FUNCTION OR NOT, INCLUDING BUT NOT LIMITED TO:
 - (A) ALL CONTACT LENSES;
 - (B) ZERO-POWERED PLANO LENSES:
 - (C) COSMETIC LENSES:
 - (D) PERFORMANCE-ENHANCING LENSES;
 - (E) ANY LENS DESIGNED TO FIT OVER THE CORNEA OF THE EYE OR
 - (F) OCULAR PROSTHESIS

ALL CONTACT LENSES SHALL BE DISPENSED IN ACCORDANCE WITH A VALID WRITTEN PRESCRIPTION DESIGNATED FOR CONTACT LENSES.

Investigator's Report

Investigator Lehman presented, and, the Board accepted a progress report regarding disciplinary cases. Investigator Lehman reported to the Board of an increase in the number of calls related to illegal dispensing/selling of contact lenses. Mr. Lehman expressed belief that this was because of the additional interest generated in these items due to Halloween.

AAG Casey stated that the Board may wish to consider different approaches to monitoring the illegal sales/dispensing of contact lenses on a larger scale by involving a larger number of individuals across the state, including the use of press releases to help inform the public of this health issue.

Attendance at January 25-27, 2007 Conference, St. Petersburg, FL:

Director Manns informed the Board that the Board had previously voted to send the Executive Director and President to the National Committee of Optical Regulatory State Boards in St. Petersburg, FL. for the January 26-27, 2007 conference. President Capretta cannot attend and it was agreed by consensus that Vice President Bitonte will attend in the president's place.

The free presentation was designed specifically for new Board Presidents and Presidents Elect with presentations and conversations on key board leadership challenges. President Capretta was unable to attend so it was agreed by the Board to ask Joe Bitonte and Jim DeDario to attend this presentation. Both agreed to do so. Mr. Bitonte and Mr. DeDario will provide feedback to the Board at the December, 2006 Board meeting.

Other Issues/Discussion/Reports from Board Members

Board member Michael Hall requested that the Board discuss as part of the review of Board approval of continuing education at the December, 2006 Board meeting Rule 4726-11-02(E)(1) OAC that prohibits the Board from approving continuing education credit for "seminar content [that] includes the promotion of commercial products or services for the practice of opticinary or ocularistry."
